Awards & Scholarship Committee Meeting ECM-126

Sofia, September 30, 2017

Attendance

The meeting was opened at 0912 and closed 0958.

The attendance sheet is listed in Appendix A.

11 out of the 18 ASC members were attending together with 17 observers, for a total of 28 attendees.

Agenda and Minutes

The agenda and the minutes were available on the IUVSTA webpage by Sept 25, 2017.

The agenda was approved.

The minutes of the ASC meeting of ECM-125 in Rogla, Slovenia as they are on the website were approved.

Welch Scholarship

A phone call with Ken Bro by David Ruzic and Martin Wüest occurred on Friday Sept 29, 2017. Mr Bro repeated his intent to fund the award with USD15000. One of his sisters from Australia might contribute. Mr. Bro also intends to put in his will that after his death his estate should continue to fund the Welch Award with 4% of his estate.

Discussion centered on how to restart the award and how to streamline the administrative process.

Legal documents relating to the relationship of IUVSTA and AVS regarding the Welch award could not yet been found.

Lars Montelius suggested to treat the funding by Ken Bro as a completely new trust and set it up the way we want it now and not rely on the structure of the original trust.

Proposal by David Ruzic

1. Kenneth Bro donates USD 15k to the AVS for use for the IUVSTA Welch Award

- 2. The AVS Board of Directors agrees to pass that money through to the recipient as directed by the IUVSTA Welch Award Committee. No administrator is needed.
- 3. The STD appoints new Welch Award Trustees, for staggering terms according to the old matrix and same procedures as written now.
- 4. The STD solicits volunteer laboratories from IUVSTA member countries to host a Welch Awardee at no (direct) cost to them. They still need to supply office space, email access, and collaborators / lab equipment etc. to the visitor.

(This could be done in the next week)

- 5. With this list we now try to get applicants. We tell them that the award is for USD 15,000 and that money is for their transportation and living expenses for at least 3 months at one of the labs on the list. They write a proposal include their CV, letters etc. I suggest the applicant needs to be a person between **negative one year to plus two years from their PhD**. This gives us more flexibility.
- 6. The Welch award committee selects a person
- 7. In June 2018 at the big meeting we will have in Geneva we make the announcement. Maybe Mr. Bro even wants to come....
- 8. In the Fall 2018 or sometime during the next year the person uses the funds and goes to the place.

The ASC meeting was in part continued during the STD meeting, with David Ruzic, the STD director, chairing.

Volunteers for the Welch Committee were signed-up. They are listed in Table 1.The terms have been assigned by the ASC chair after the meeting.

- Message from the lawyers of the Welch family: Make an endowment instead of a yearly donation (300 kUSD?)
- Mrs. Bro died in 2013. Donation stopped
- Estate in litigation and no money was transferred. IUVSTA suspended the Award
- No award given since 2013

Latest Developments (March 2017)

 Kenneth Bro, grandson of Medard W. Welch wrote in an Email on March 11, 2017 to David Ruzic that he intends to fund the scholarship in part from his own charity giving.

Latest Developments (29 Sept 2017)

- Kenneth Bro is committed to restart the Welch award. One of his sister from Australia also indicated that she might contribute.
- His thoughts are to donate yearly USD 15'000 to AVS, the same way it was done before, to get a US 26 CFR 1.501(c)(3) tax deduction.
- He intends to write in his will that the estate should continue to write Welch Award checks in the amount of 4% of his endowment at that time.





Allowance of 501(c)(3) tax-deduction by donors

- Donors' contributions to a 501(c)(3) organization are tax-deductible only if the contribution is for the use of the 501(c)(3) organization, and that the 501(c)(3) organization is not merely serving as an agent or conduit of a foreign charitable organization. The 501(c)(3) organization's management should review the grant application from the foreign organization, decide whether to award the grant based on the intended use of the funds, and require continuous oversight based on the use of funds.
- If the donor imposes a restriction or earmark that the contribution must be used for foreign activities, then the contribution is deemed to be for the foreign organization rather than the 501(c)(3) organization, and the contribution is not tax-deductible. [42]

- 1. Dr. M. W. Welch was Honorary Chairman of the Welch Scholarship Trustees during his lifetime.
- 2. His daughter Mrs. P. Bro and her husband Mr. K. Bro are honorary members of the Welch Scholarship Trustees.
- 3. The Trustees comprise six other members:
- 4. The Chairman of the Scientific and Technical Directorate of the IUVSTA, who is ex officio chairman of the Welch Trustees; the treasurer of the IUVSTA, who may delegate operational authority; four shall be to evaluate the scholarship applicants.
- 5. The four elected members of the Welch Trustees shall be elected by the Executive Council of the IUVSTA. Any member of the Executive Council shall be entitled to make nominations; the Chairman of the Scientific and Technical Directorate shall in any case propose candidates to the number of vacancies to be filled. In the election of members of the Welch Trustees, the Executive Council should have in mind the importance of ensuring, so far as is practicable, equal representation from industry, from research institutes and from universities. Candidates shall be considered purely on the basis of their scientific qualifications, independently of any connection with the IUVSTA. The elected members shall be of different nationalities and, so far as possible, should be expert in different fields of science and technology.

Purpose

Eligibility

The nominee must have accomplished outstanding experimental and/or theoretical research in vacuum science, technique or its applications within the ten years preceding the year in which the award is made. Special consideration will be given to nominees currently engaged in an active career of research.

Neither nominees nor nominators are required to be members of IUVSTA member societies. The award will normally be given to an individual; however, in exceptional cases involving team research, multiple awards may be given. The prize will be granted without further restriction except that current officers and members of the Executive Council and Standing Committees, as well as Division officers, are not eligible.

Judges for the Prize will be a committee appointed by the IUVSTA President and chaired by the IUVSTA Scientific and Technical Director. The decision of this panel is final.

Nature of the Prize

The Prize consists of a cash award, a struck medal and a certificate setting forth the reasons for the award. The Prize will be conferred at intervals of not less than three years. Reasonable travel expenses of the awardee to the meeting at which the Prize is presented shall be agreed upon and reimbursed.

Review procedure

The whole process from announcement to the award ceremony is directed by the Awards and Scholarships Committee (ASC) and its chair.

The most important tasks are:

- a) to solicit nominations, looking through the submissions, taking care for their completeness,
- b) to form the juries, preferably from the members of the ASC. Possible conflicts of interests have to be carefully avoided.
- c) to organise the work of the juries, including the distribution of the complete submitted material via e-mail. The ASC chairman has to verify that the submitted printed material and the electronic versions are identical. The prize winners are determined by the juries after careful discussion by e-mail voting. The decision of this panel is final.
- d) taking care of the fabrication of medallions and diplomas.

- c) to organise the work of the juries, including the distribution of the complete submitted material via e-mail. The ASC chairman has to verify that the submitted printed material and the electronic versions are identical. The prize winners are determined by the juries after careful discussion by e-mail voting. The decision of this panel is final.
- d) taking care of the fabrication of medallions and diplomas.
- e) to liaise with the organisers of the IVC in order to make sure the IUVSTA Prizes are properly presented at the IVC and plenary lectures be assigned to the prizewinners.
- f) after the prize ceremony the electronic documents about the submission and decision procedure are given to the IUVSTA archive. The printed material has to be shredded by the ASC chairman.

- Then, we have to state officially the amount of the prize, the participation to extra expenditure (hotels, trip, etc...), the waiving of the conference fees, all the questions that we dealt with too late in May this year.
